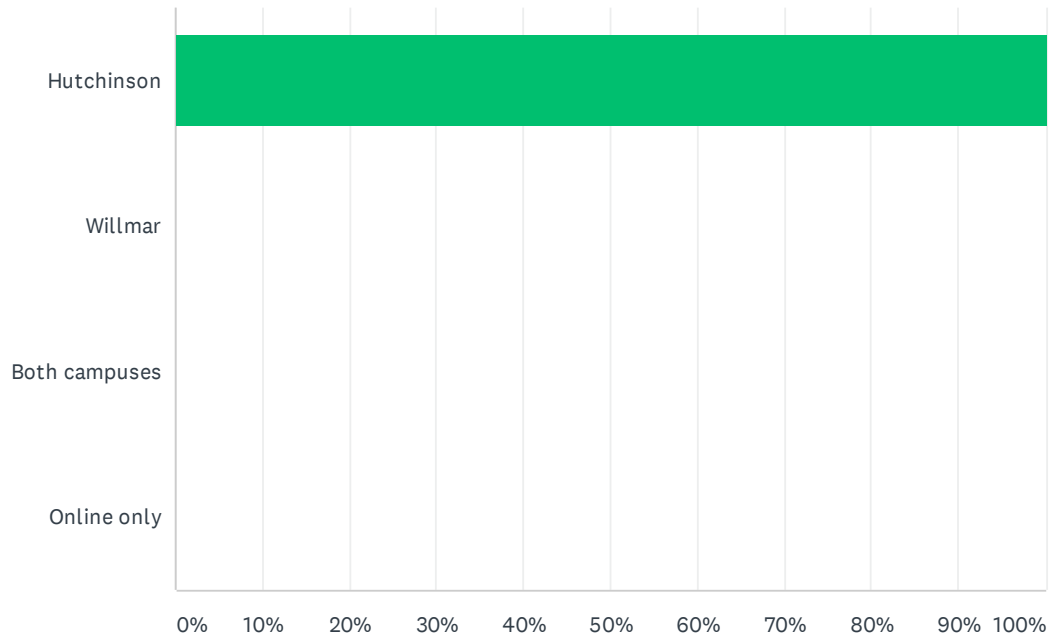

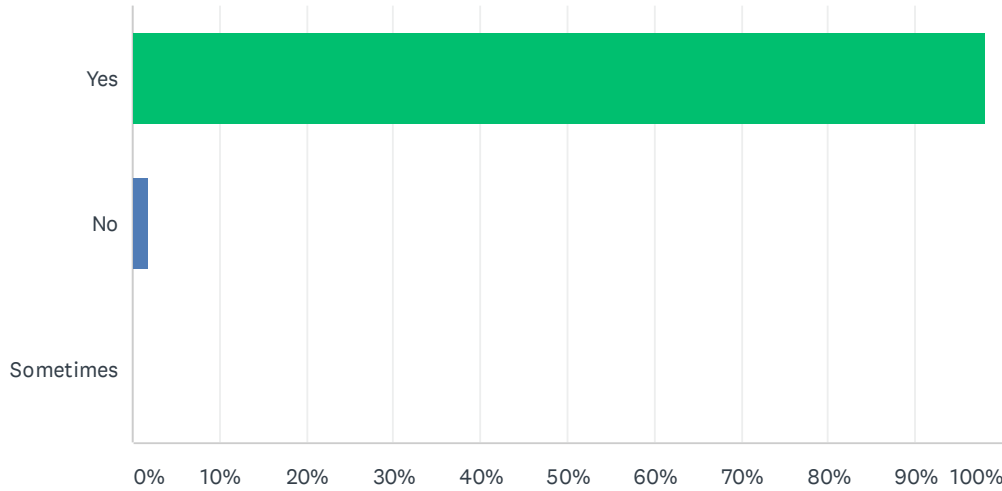

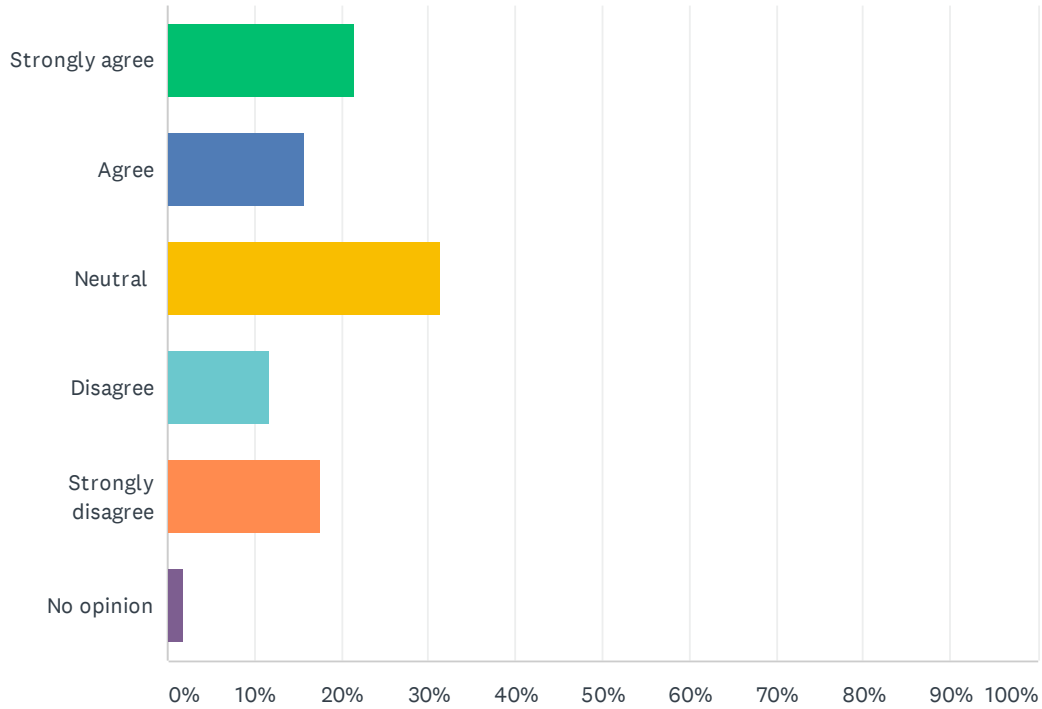

## Q4 Campus parking should be equally available to students and employees on an open basis in all parking lots.

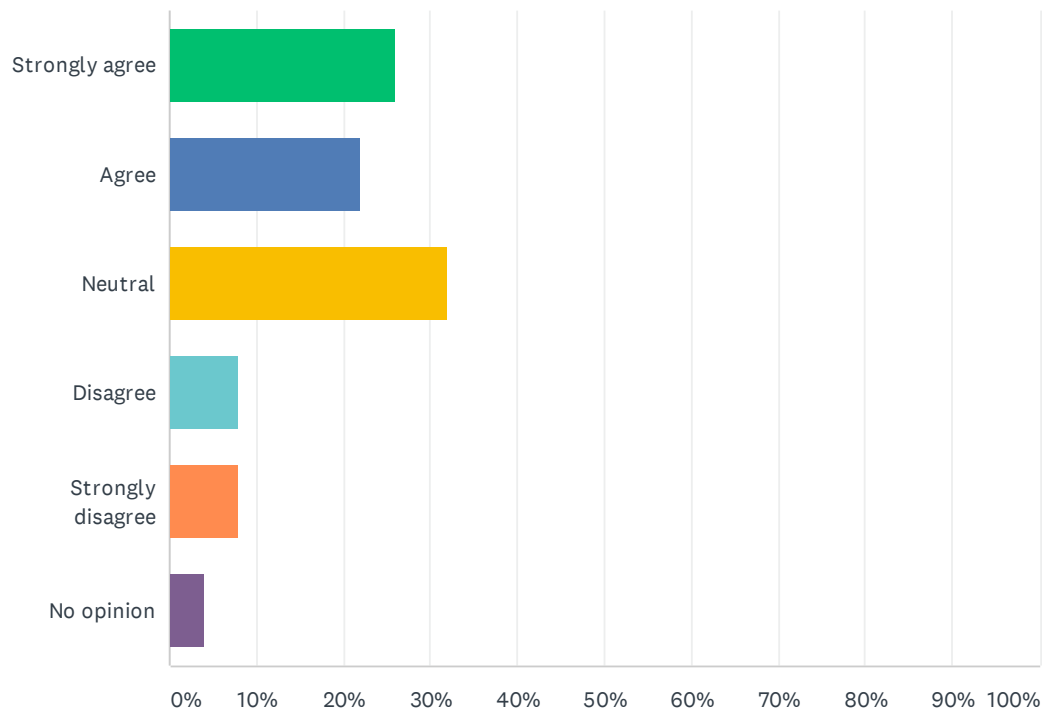

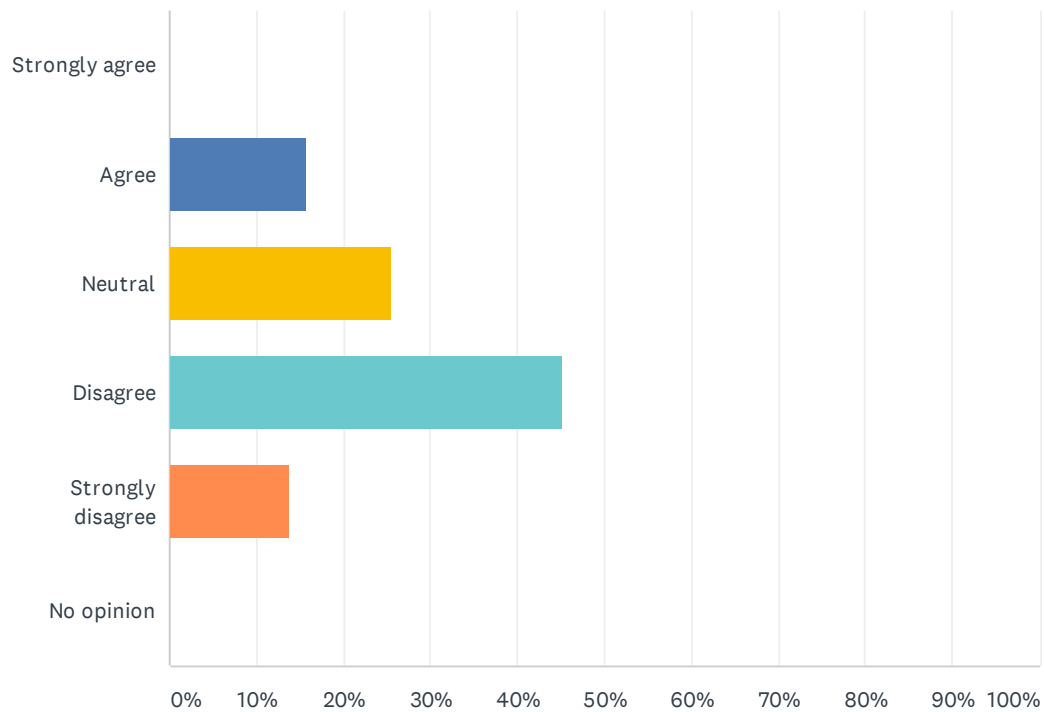

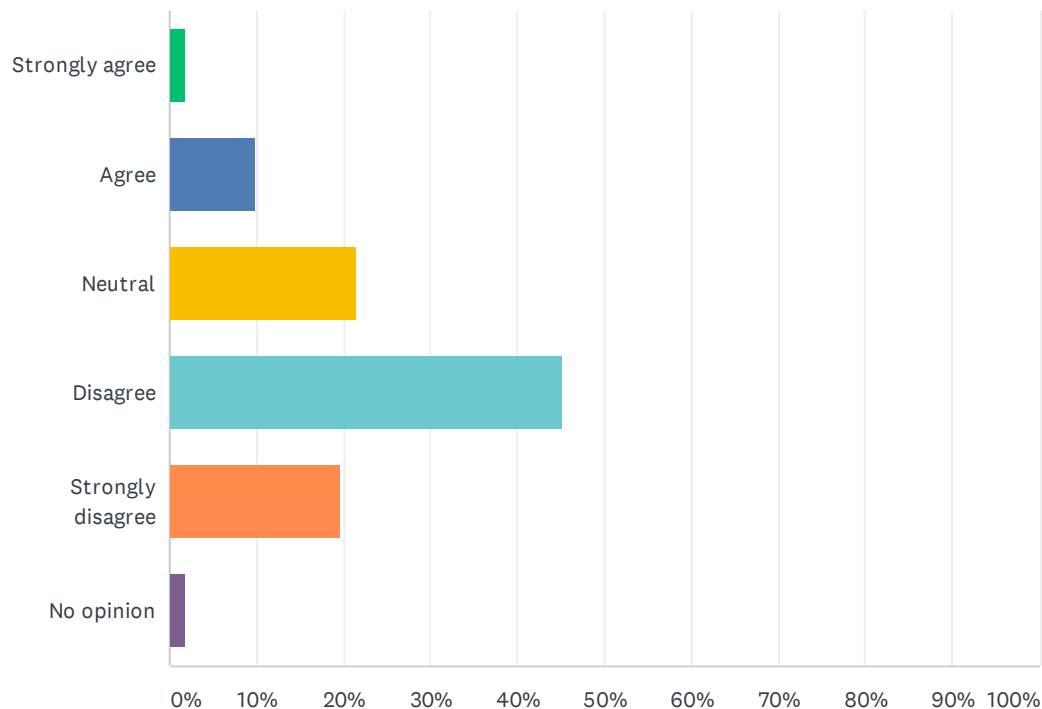

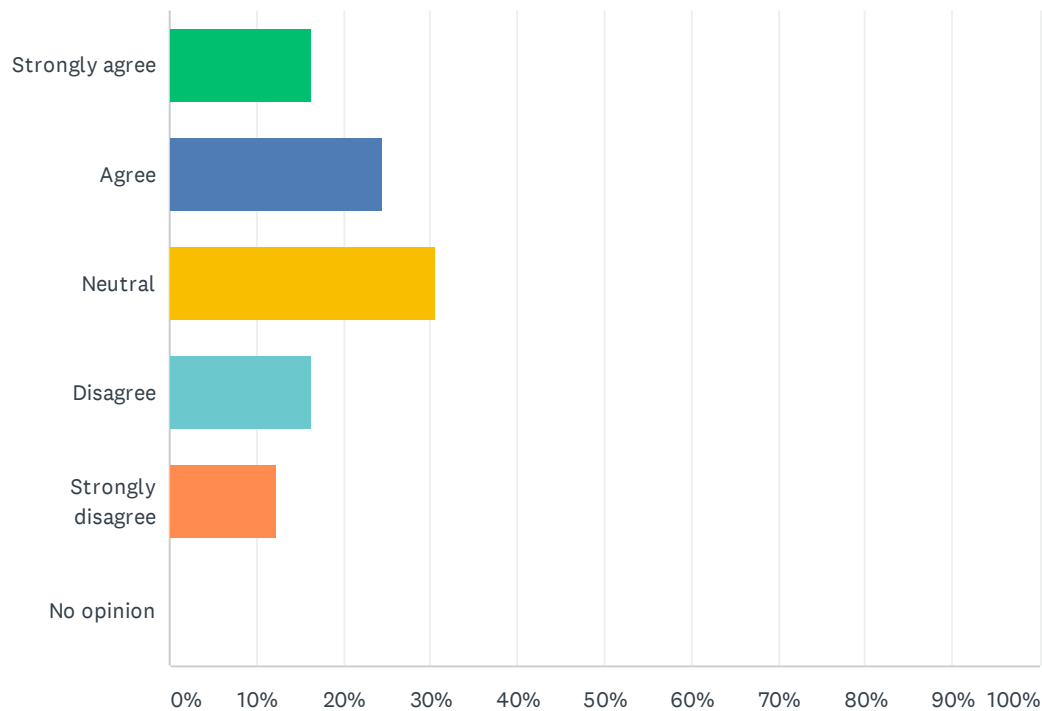

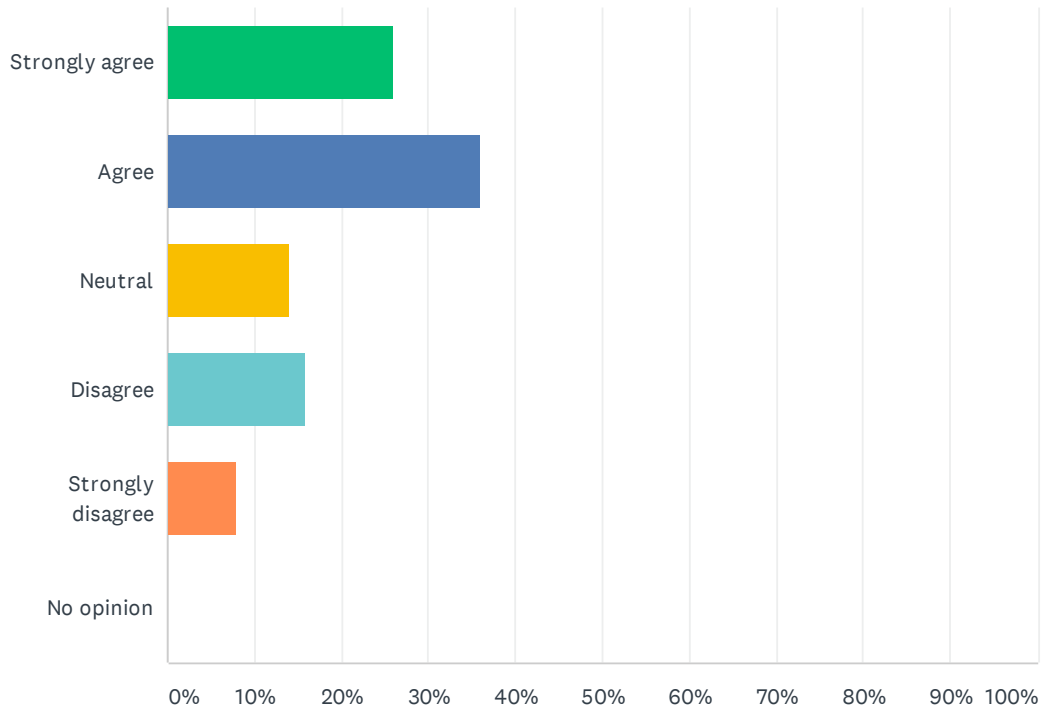

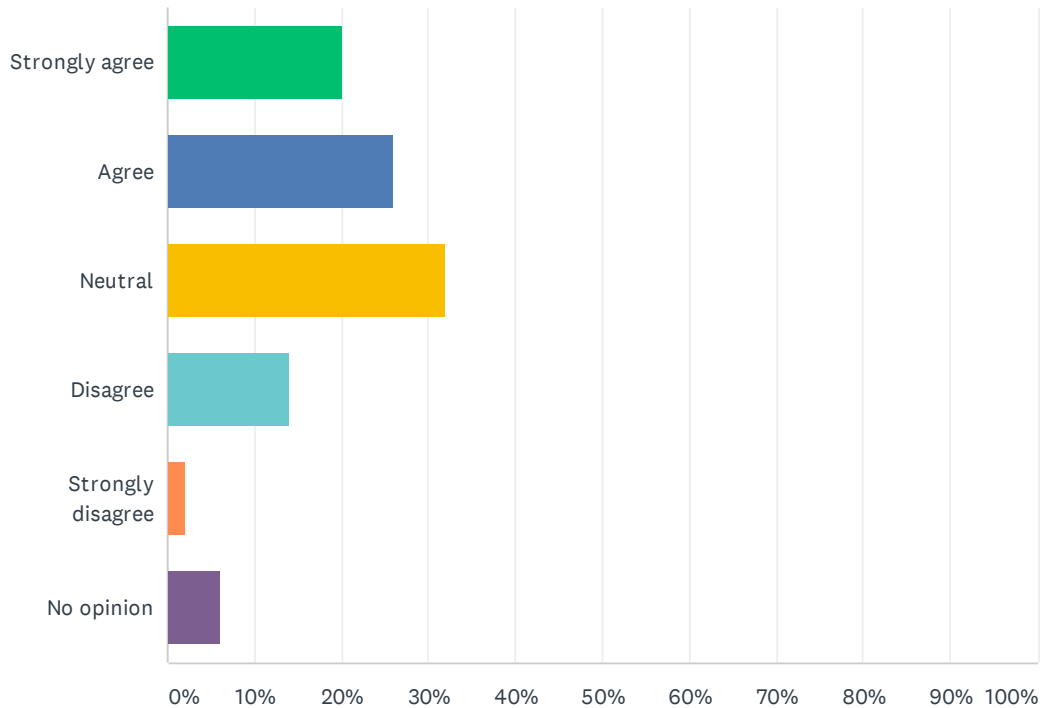

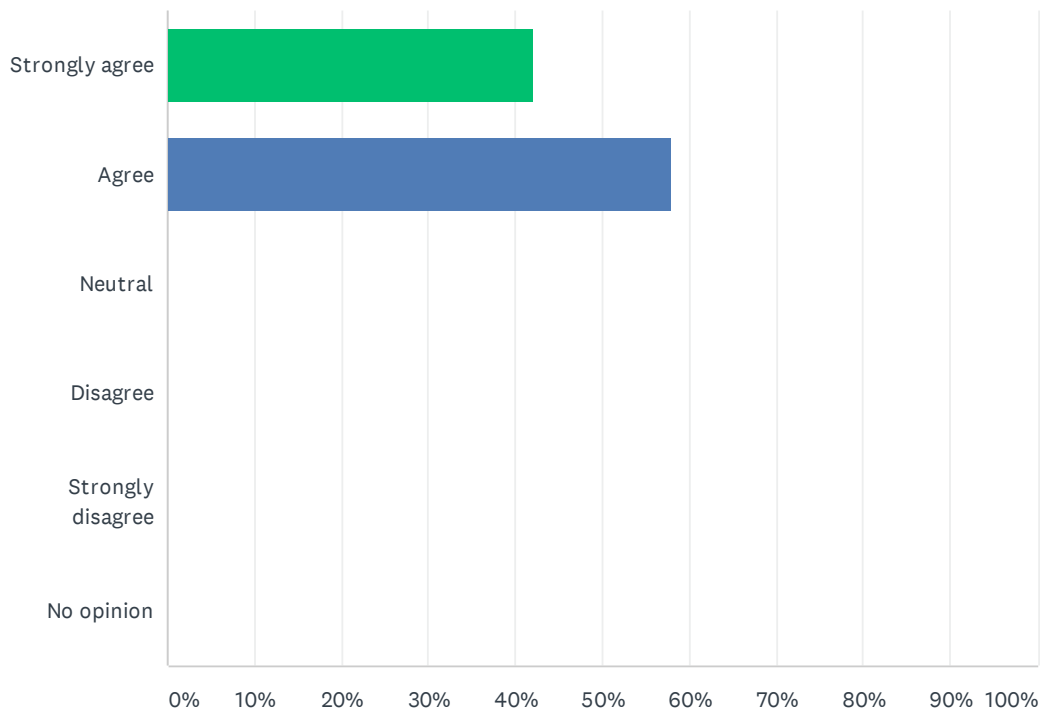

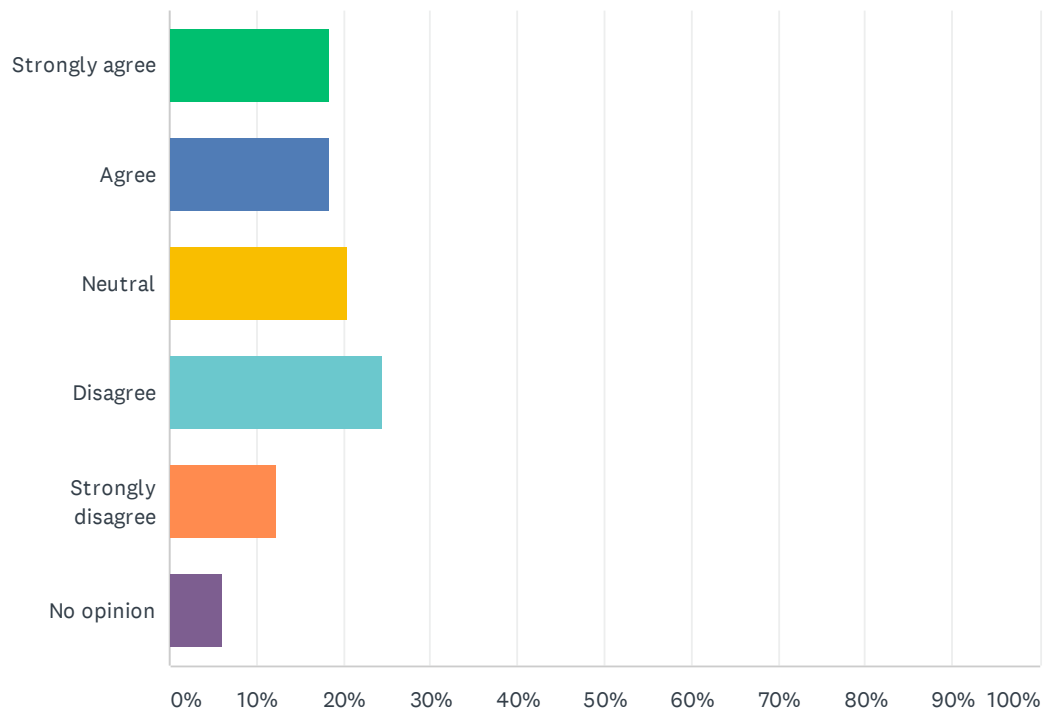

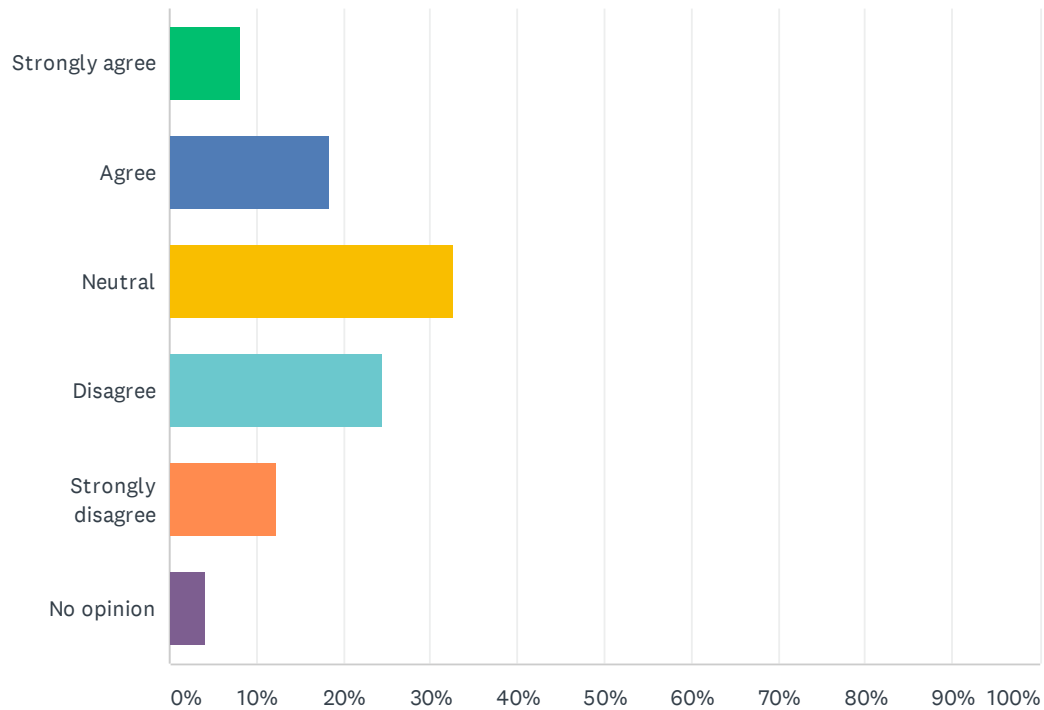

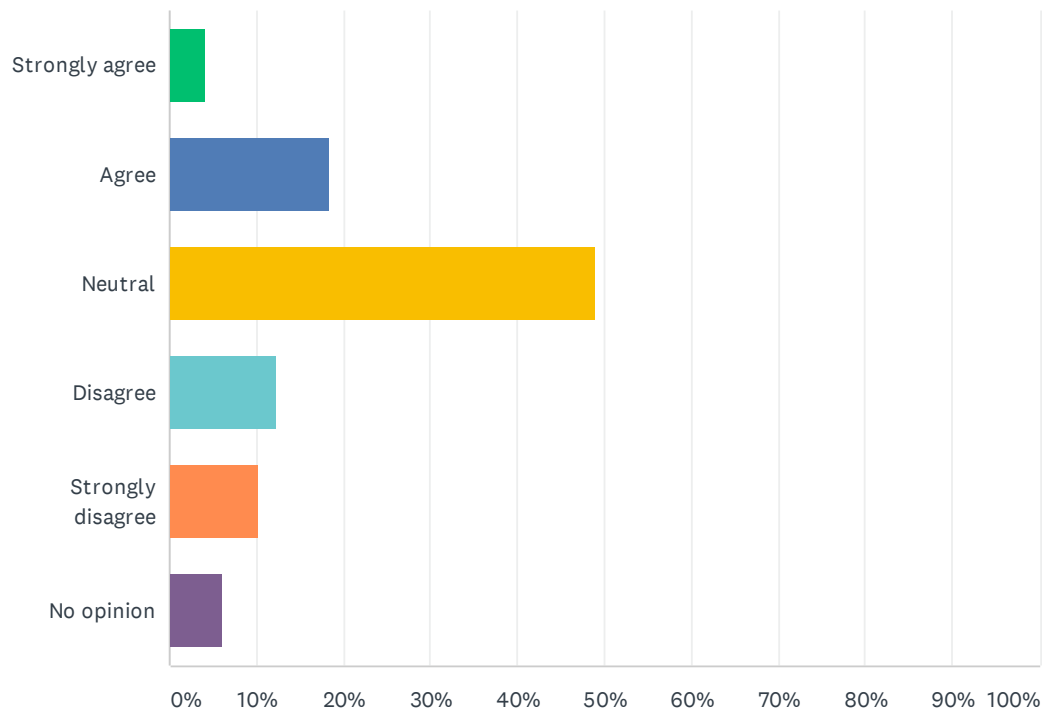

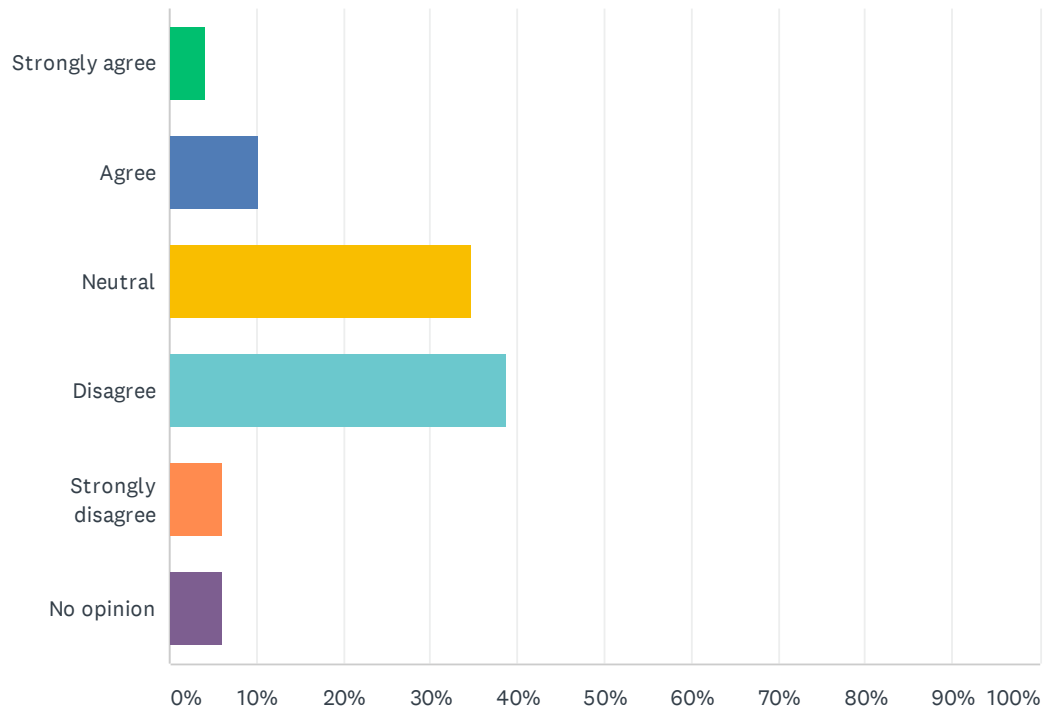
